

# IIEE Admission Criteria Batch 2021

## Institute of Industrial Electronics Engineering

### Adoption of Revised Admission Criteria of B.E First Year of NED UET in IIEE Admission Process 2021

In continuation of the sporadic circumstances of global widespread of COVID 19, the academic activities in the country are also being effected in 2021. The HSC exams have been postponed and expected in July 2021. Thereupon, it will lead to late announcement of the result of HSC II and delayed induction of Batch 2021.

The state of Spread of Corona and its variants may unexpectedly accelerate as precedent since 2019. Therefore, there is a need of devising a flexible admission policy to cater unforeseen situations without deviating from IIEE academic calendar. These consequences are judged by the authorities of NED UET and to combat against them, the eligibility and merit criterion for the induction of Batch 2021 in B.E at NED UET are revised accordingly and presented in 152<sup>nd</sup> Academic Council meeting held on 24<sup>th</sup> May 2021. The minutes of the meeting were circulated which give an insight that being an affiliated institution, the same eligibility and merit criterion may also be adopted at IIEE.

The admission process at IIEE is in line of NED UET statutes for affiliated institutions and HEC/PEC guidelines. The applicants of IIEE appear in the entry test of NED UET and are given admission on the same merit criteria as prescribed by NED UET. In 2020, a Pre Admission Entry Test specifically to entertain the students on country wise quota for IIEE applicants was also conducted and administered by NED, UET.

It is therefore, requested to kindly allow IIEE to adopt the revision in the criteria of the admission in First year Undergraduate program of NED, UET as mentioned in minutes of 152<sup>nd</sup> Academic Council meeting of NED UET in IIEE admission process. The following three possible options are presented:

#### **Option-1;**

Start the admission process for session 2021 at IIEE after the announcement of intermediate and equivalent examinations by concerned boards/examining bodies. The previously approved eligibility criteria for session-2019 admission and earlier which is reproduced below will be followed.

Merit Score = HSC Marks + Entry Test Marks

**Note: This may lead to start of academic session in the month of December-2021. This option can ONLY be considered if the examinations are held during the month of July, 2021 as otherwise, the session will get substantially delayed.**

#### **Option-2;**

Offering provisional admission based upon the marks secured by the individuals in

SSC/Equivalent Examination and Pre-Admission Entry Test with the weightage being 30% and 70% respectively.

Those candidates who had their HSC/A-level qualified during earlier years will have 50% weightage to complete result i.e. HSC /A-Level. Note: This is as practiced by several public sector universities.

**Note: The admission will be confirmed only after the candidate submits his/her final marks being minimum 60% .**

**Option-3:** Any other Policy (if at all) announced by HEC/PEC

**Tie in Merit Position:** The tie in merit position shall be resolved as per the policy approved last year which is reproduced as under:

- a) Aggregate marks obtained in Pre-Admission Entry Test shall be the criterion for resolving the merit.
- b) Any further tie shall be resolved by considering the following criteria:

For applicants with Pre-Engineering Science: marks obtained in sections of Mathematics, then Physics and then Chemistry of Pre-Admission Entry Test.

**For Approval:**

- a) Above three options of admission criteria are placed before IIEE Board of Studies and Academic Council NED University for consideration.
- b) It is further proposed that the IIEE may be allowed to opt anyone option mentioned above depending upon the prevailing situation of the Country with respect to COVID-19 and government directives.

The opted policy will be submitted in the subsequently.
